Rules

Eligibility

- Entry is open to residents of NSW, aged 18 or over, who attend any of:
 - The Great Australian Beer SpectAPular Sydney 2018 event (held on Saturday 2 June 2018); or
 - The Coastal Brewing Company tasting room on Friday 8 June 2018, Saturday 9 June 2018 or Sunday June 10 2018; or
 - the Central Coast Beer and Cider Festival 2018 event (held on Sunday 10 June 2018).

These events are the eligible events.

- Employees, immediate family members of employees, employees of any company associated with the Promotion are ineligible to enter

Entry

- The Promotion commences at 11:30 on Saturday 2 June 2018 and entries close at 17:00 on Sunday 10 June 2018 (promotion period)
- To enter, Eligible Entrants must, during the Promotion Period:
