

# **The Coastal Brewing Company Pty Ltd**

## **Old Bar Beach Festival Merch Draw**

### **Rules**

#### **Eligibility**

- Entry is open to residents of NSW, aged 18 or over, who purchase a four pack or more of the 2024 Old Bar Festival Limited Release Palms Pale between Thursday 12 September and Thursday 5 December 2024.
- Employees, immediate family members of employees and employees of any company associated with the Promotion are ineligible to enter.

#### **Entry**

- The Promotion commences at 11:30 on Thursday 12 September 2024 and entries close at 17:00 on Thursday 5 December 2024.
- To enter, Eligible Entrants must, during the Promotion Period:
  - Scan the QR code on the top of the four pack;
